A call of the roll reflected that a quorum was present.

Receive the Human Resources Actions Mr. Billups presented the Human Resources Actions for approval at the 7:00 p.m. School Board meeting.

Receive Articles VII, VIII, and IX of the Personnel Section of the Bylaws and Policies Manual This item was deferred to the 7:00 p.m. School Board meeting.

Receive a Report from Restorative Justice at Armstrong High School It was shared that the City of Richmond Department of Justice Services (RDJS) had partnered with Richmond Public Schools, Restorative Youth Services of Virginia, and Communities in Schools to develop a pilot Restorative School Program at Armstrong High School. The program was designed as an alternative way to respond to conflict. The Armstrong Restorative School Program consisted of five core elements (1) the restorative classroom, (2) restorative circles that were initiated by community members (3) teacher/staff peer support circles (4) transition circles for returning and new students, and (5) a commitment to build self-sustaining restorative community.

Receive a Report on Virginia High School League (VHSL) Mr. James reported that an Athletic Task Force was recently formed by Richmond Public Schools and had partnered with several organizations within the city to identify strategies for developing a continuum of sports and athletic options for students from elementary to high school. The Athletic Task Force recently met and recommended the formation of a new athletic district or reclassification under the Virginia High School League. The recommendation was based on a desire for a more balanced competitive district to allow RPS athletes to compete with other schools of similar size and talent. The committee presented several options for consideration by the VHSL. There were many members of the community present to share their concerns regarding the current state of the athletic disparities between the city schools and those of the surrounding counties.

Public Information

Diane Watkins, President and Founder of Bells for Peace, Inc., extended an invitation to School Board members to attend the Virginia Union University (VUU) dedication of the newly installed electronic carillon at the Belgian Friendship Building. The dedication ceremony would commence on Wednesday, November 16, 2011, at 1:30 p.m. with the ringing of the bells. Ms. Watkins provided background and history of the VUU's Belgian Friendship Building.

Approve the Minutes of the September 19, 2011, September 26, 2011, and the October 3, 2011 Meetings The minutes of the September 19, 2011, September 26, 2011, and the October 3, 2011, meetings were approved.

Receive Updates from School Board Representatives on the: Appomattox Governor's School Regional Board, Head Start Policy Council, Richmond Council of PTAs, Richmond Chamber of Commerce Education Committee There was no report at this time on the Appomattox Governor's School Regional Board.

Mr. Henderson reported that the Head Start Policy Council held its parliamentary training for new members. The council reviewed the first month of operational results for the Head Start Program in Richmond, Powhatan, and Petersburg. There were discussions regarding strategies to increase the attendance and participation of parents in the Head Start Program and parents whom benefited from the program.

There was no report at this time on the Richmond Council of PTAs. Mrs. Bridges announced that Chimborazo Elementary and Huguenot High Schools were winners of the local PTAs Outstanding membership recruitment division award for the 2010 school year. They each received a third place award.

Mr. Coleman reported that the Richmond Chamber of Commerce Education Committee in conjunction with the Greater Richmond Chamber and Business Council held a breakfast for the top ten finalists for the 2012 Teacher of Year honorees. Dr. Brandon announced that the Teacher of the Year finalist would be recognized at the next School Board meeting.

Receive Articles VII, VIII, and IX of the Personnel Section of the Bylaws and Policies Manual Attorney Lilly provided an overview of Articles VII, VIII, and IX of the Personnel Section of the *Bylaws and Policies Manual*.

- Policy 7-7.17 Employee Absences/Leave
 Attorney Lilly would research surrounding districts policy regarding civil leave and bring forth language that would be considered as a first read.
- Policy 7-9.6 Electronic Communication.
 Attorney Lilly would add language regarding a policy statement that encouraged the innovative use of technology to enhance the learning process.
- Policy 7-9.7 Use of Private Cars for Transporting Pupil. Attorney Lilly would research surrounding districts policy regarding the pick-up and safe delivery of children from one destination to another.

The Board would have a first read of the entire Personnel section at its meeting on November 21, 2011.

As a follow up to the October 3, 2011Grievance Training, there was further discussion by the Board regarding adding gender orientation as a protected class to the policy statement. Attorney Lilly shared that law prescribed the protected classes that were previously discussed and gender orientation was not. Based on the research that was reviewed it was noted that the Arlington School System had incorporated the language into its policy statement. Attorney Lilly noted that it would be up to School Boards whether to add gender orientation to its policy as a protected class. Attorney Lilly suggested that the Board may want to wait until the General Assembly took up the issue in the session that was proposed by the VSBA regarding protected classes. Ms. Gray would

forward the language from the City regarding policy changes. Mrs. Smith would bring forth VSBA Delegate Assembly discussion from the November 16, 2011 meeting and the VSBA vote. Attorney Lilly provided a recap of the grievance process for support staff personnel, which by law did not require a fact-finding panel hearing. It was being proposed that the recommendation of termination or grievance for support staff personnel would be a decision made at the management level with the option to go before the School Board. At the November 21, 2011 meeting, the School Board would consider the gender orientation policy statement and support staff personnel grievance process.

Receive a Report from the Garden Task Force

A PowerPoint presentation was shared that showcased projects of the Garden Task Force over the last year. The Garden Task Force goal was to enhance the awareness of students of the gardening possibilities in a diverse and urban setting with school administrators, teachers, and community partners. Dr. Marrow provided comments on the Garden Task Force.

Receive an Update on Building a Better Richmond

Mr. Hawkins reported that the elementary school was ahead of schedule. The abatement of materials at Martin Luther King, Jr. Middle School would be completed on November 11, 2011. The City Procurement office would post the demo package award recommendation to hire J. D. Lewis on November 7, 2011. Photos of elementary projects of the Oak Grove and Board Rock Elementary Schools were shared. There were plans for an upcoming demo event planned for MLK that would be coming soon.

Receive a Report on Operations

Mr. Hawkins provided a review of the Cigna Health Insurance employee satisfaction survey for Richmond Public Schools. The 750 employees that were surveyed out of 8,000 employees indicated that overall 96 percent of the employees were satisfied with the services. Highlights of how the district could improve health services were reviewed that included well care visits, availability of care clinics and urgent care facilities, health assessments, and healthy baby programs.

Receive an Update from the Re-zoning Task Force

Mr. Hawkins reported that the Rezoning Task Force meeting on October 25, 2011 was conducted by Cropper GIS Consulting. The committee of 40 members met and discussed GIS role. The committee was provided data that consisted of school capacity, maps, and live birth rates for their review. There was also a discussion on strengthening weakness analysis of what the district should consider as it rezoned. The next meeting for the Rezoning Task Force was scheduled on November 15, 2011 at 6:00 p.m. at the Richmond Technical Center.

Dr. Brandon shared information on the Fox Elementary School Celebration of its Centennial event that was held on November 6, 2011.
